



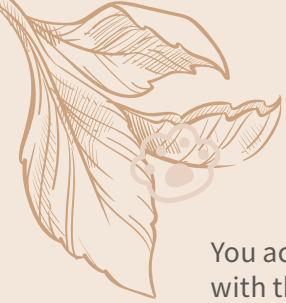
## WAIUER OF LIABILITY

By allowing your minor/child to enter our cat lounge area, you agree to the following Release of Liability, Covenant Not to Sue, and Assumption of the Risk and Indemnification:

YOU THE PATRON (WITH OTHER PATRONS) AND/OR REPRESENTATIVES/GUARDIANS OF THE MINORS, ACKNOWLEDGE AND AGREE TO THE FOLLOWING:

1. That interaction with cats can result in injury, including, but not limited to, biting or scratching without warning or provocation. By entering the cat room and executing this "Release of Liability, Covenant Not to Sue and Assumption of the Risk and Indemnification", You knowingly, voluntarily and willingly assuming all liability and assumption of the risk related to interaction with the cats. This includes, but is not limited to, injuries of any kind, bites, scratches, infections, illness, allergies, and physical, emotional and financial injuries and damages, some or all of which may be severe (hereinafter collectively referred to as the "Injuries").
2. That the cats in CAT CONNOUISSEUR come from all different backgrounds. They are in good health and temperament to the best of their knowledge. This does not in any way guarantee the behavior, or health of the cats it provides.
3. You will treat the cats kindly, gently and with respect and appropriately watch for signs of irritation or aggression from the cats.
4. Though CAT CONNOUISSEUR strives to provide only those cats that have received appropriate and sufficient medical care, it cannot guarantee the health, mental stability, and/or the lack of parasites or any other attribute or condition.
5. If Injuries occur which require medical or other treatment of any sustained directly or indirectly as a result of entering the cat room or any activity involving or related to animals at CAT CONNOUISSEUR, you agree to be fully liable, legally, financially or otherwise for any and all costs, expenses or other burdens incurred as a result of such care.
6. You fully understand the potential for risks and the conditions indicated within and hereby agree that you, on behalf of myself and my heirs, executors, guardians, administrators, legal representatives, successors and assigns, promise to not bring, support, or cause to be brought any claim or action, legal or otherwise against CAT CONNOUISSEUR, and their respective owners, employees, partners, vendors and volunteers.



You acknowledge that CAT CONNOISSEUR staff will not monitor or assist with my interaction with the cats, but instead will remain available to generally monitor the activities and the activities of other participants. Staff will be available to generally assist or encourage interaction. CAT CONNOISSEUR makes no guarantees about any level of monitoring or control of the cats. You acknowledge that you will comply with all instructions and rules, and that failure to do so will result in prohibition from further participation. You further acknowledge that you will not be given a refund for my admission if you violate the instructions and/or rules.



In consideration for your participation and/or the participation of the minors in your care in the activities at CAT CONNOISSEUR, you hereby waive, release, discharge, and covenant not to sue CAT CONNOISSEUR and their owners, affiliates, employees, agents, or other involved vendors (hereinafter collectively referred to as the "Releasees") from and against any claim or cause of action, arising out of or related to any loss, damage or injury, that you may sustain while participating in the activities at CAT CONNOISSEUR, resulting from any cause, including, but not limited to, any inherent risk as exists with animal interactions. you assume and accept all risk for your participation in these activities, including, but not limited to, personal injury, death, and property damage.

You understand that any Injury or other outcomes may arise from my own or others' actions, inaction, or negligence and I nonetheless assume all related risks known and unknown to me.

You are of sound mind and body, and acknowledge that you have read and understood the above waiver and, having determined to proceed of your own volition without coercion or intimidation, intend to be bound by the terms thereof.
